Assessment

The Defaqto methodology involves using both quantitative and qualitative inputs to risk rate a fund:

Input 1 - Forecast the fund's future volatility

Input 2 - Discussion with the fund manager

Since our profiles are overlapping and not contiguous, we have some discretion as to whether a fund is rated in the upper or the lower profile.

Our assessment has been considered by our Investment Committee, and has taken into account some of Vanguard's suggestions when arriving at our Risk Ratings.

We used fund holdings supplied by Vanguard to calculate all stochastic measures. Through discussion with Vanguard in which the Defaqto methodology and their approach were considered, both Defaqto and Vanguard believe that this fund is most appropriately risk rated as a 2.

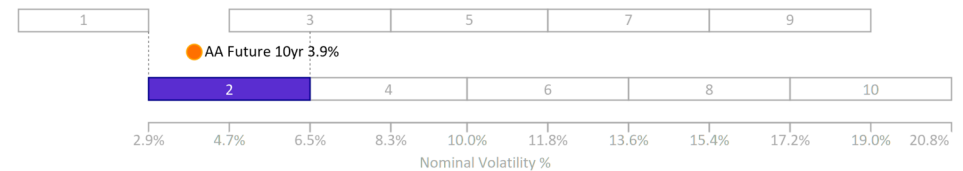

We used fund holdings supplied by Vanguard to calculate all stochastic measures. Through discussion with Vanguard in which the Defaqto methodology and their approach were considered, both Defaqto and Vanguard believe that this fund is most appropriately risk rated as a 4.

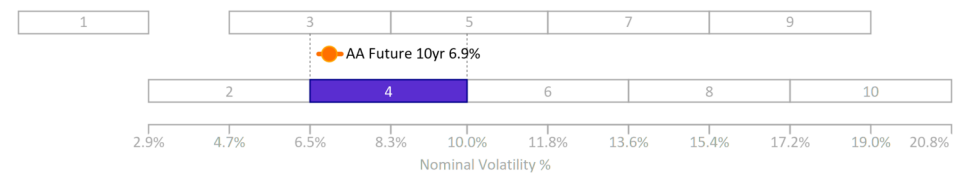

We used fund holdings supplied by Vanguard to calculate all stochastic measures. Through discussion with Vanguard in which the Defaqto methodology and their approach were considered, both Defaqto and Vanguard believe that this fund is most appropriately risk rated as a 5.

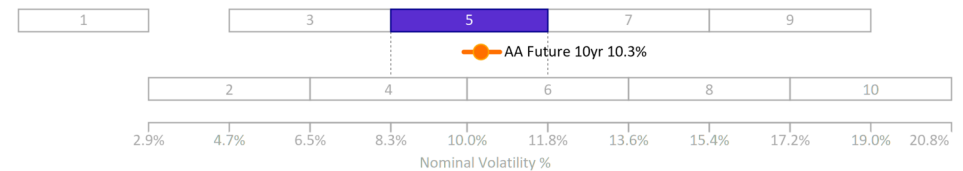

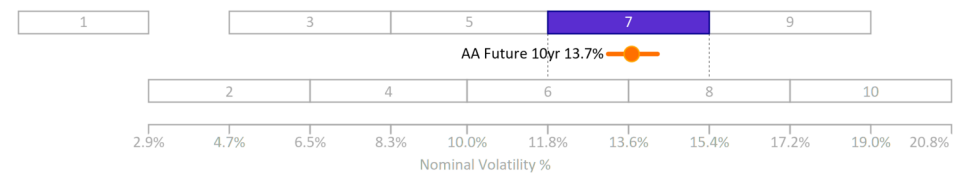
