

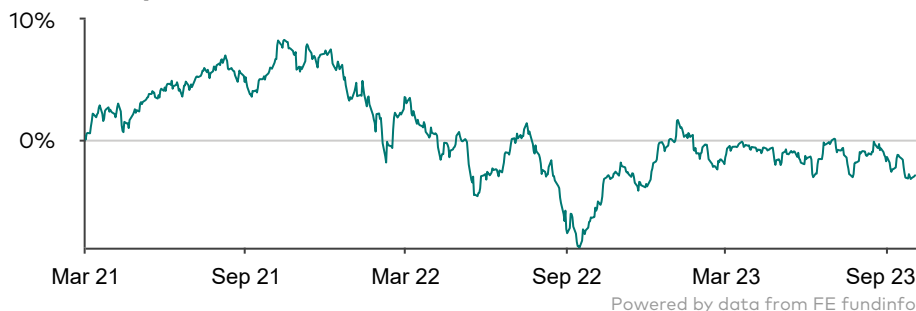
# Vanguard LifeTarget Moderate Model Portfolio

## Model portfolio objective

The Vanguard LifeTarget Moderate Model Portfolio ("LifeTarget Moderate") aims to maximize an investor's risk-adjusted return while keeping the expected return above the minimum return target of 4%, annualised over rolling 5-year time periods.

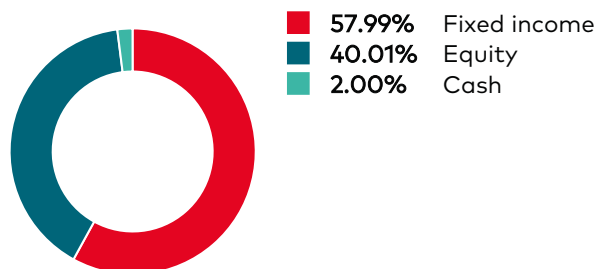

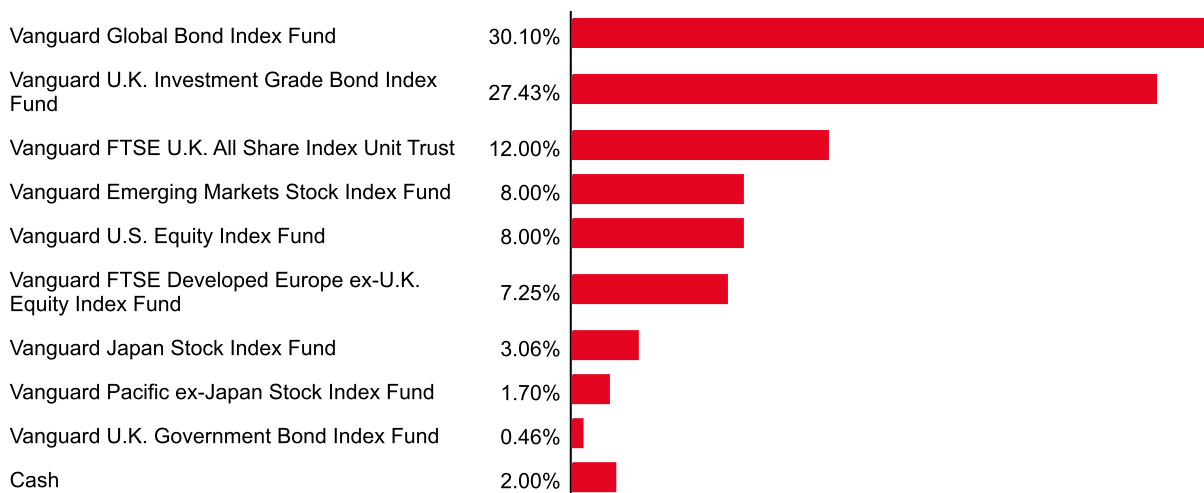

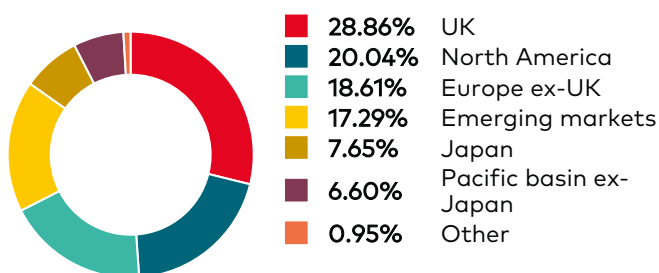

## Model portfolio breakdown (as at 31/10/2023)



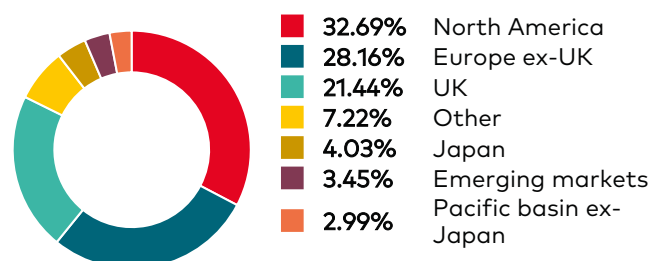

## Equity regional breakdown (as at 31/10/2023)



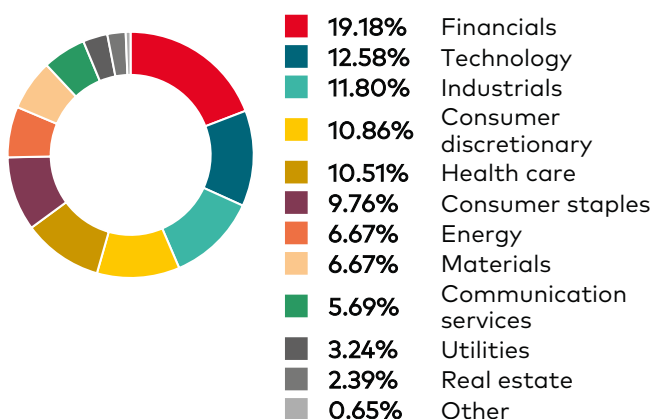

## Fixed income regional breakdown (as at 31/10/2023)



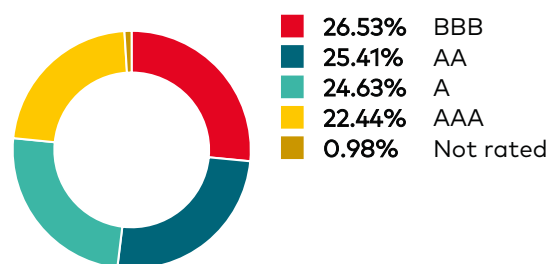
