

VANGUARD LAUNCHES U.K. SHORT-TERM GILT INDEX FUND

The product is the fourth Vanguard has added to its fixed income range in 2025

12 June 2025— Vanguard today launched the Vanguard U.K. Short-Term Gilt Index Fund. The fund further completes Vanguard's range of U.K. government bond products, complementing the Vanguard U.K. Gilt UCITS ETF, Vanguard U.K. Government Bond Index Fund, Vanguard U.K Inflation-Linked Gilt Index Fund and the Vanguard U.K. Long-Duration Gilt Index Fund, to give investors access to UK government debt across a broad range of exposures and durations.

Kelly Gemmell, head of fixed income product specialism, Vanguard, comments:

"The average maturity of the UK's debt portfolio is one of the longest among advanced economies.¹ For investors that wish to diversify the duration in their gilts portfolios, the Vanguard U.K. Short-Term Gilt Index Fund provides a high-quality way to do so."

The Vanguard U.K. Short-Term Gilt Index Fund is domiciled in Ireland and seeks to track the Bloomberg UK Gilt 1-5Yr Float Adjusted Index. The following general share classes will be available at launch and carry the following ongoing charges figures²:
