The Directors have taken all reasonable care to ensure that, as at the date of this Notice, the information contained in this Notice is in accordance with the facts and does not omit anything likely to affect the import of such information. The Directors accept responsibility for the information contained in this Notice.

to advise you of a number of changes in connection with the Company's desire to make the Share classes available in the Funds more clearly accessible and transparent to Shareholders to include:

- (a) Change of Share Class Names
- (b) Consolidation of Share Classes and Subsequent Revision of Share Class Names;
- (c) Share Classes Closing to New Investment; and
- (d) Change of Minimum Investment Amounts

further details in respect of each of these proposed changes are detailed below.

As part of this update, it is proposed to include a revised Share class table, which captures the Share classes available for all sub-funds of the Company in one table within the Prospectus, and to make certain changes as outlined below. It is proposed that the changes detailed in this Notice will take effect from 19th June 2020 (the "**Effective Date**") and will be reflected in a revised Prospectus and Key Information Documentation ("**KIIDs**") to be dated the Effective Date. Thereafter, you will see the new Share class name (as referenced in **Appendix I**) on your valuations, statements and any other correspondence you receive from the Company.

1. Change of Share Class Names

The Directors have determined to change the Share class names of a number of Share classes in order to create a simplified and consistent approach across the Company. The new naming conventions emphasise the key features of the Share classes and in doing so creates simplicity and transparencies for investors. Details of the change of Share class names are included at **Appendix I** to this Notice.

As part of the change to the Share class names, the Directors have also determined to change reference to "Income" within the relevant Share class names to "Distributing". This change will be applied in the Prospectus and KIIDs. The use of "Distributing" within the name of the relevant Share class, more closely aligns the naming convention for the Share classes of the Funds with the naming conventions widely prevalent across the UCITS marketplace.

2. Consolidation of Share Classes

Article 4.04 of the Constitution of the Company states that "The Directors are hereby authorised from time to time to re-designate any existing Series or class of shares in the Company and merge such Series or class of shares with any other Series or class of shares in the Company, provided that Shareholders in such Series or classes are first notified by the Company and given the opportunity to have the shares redeemed."

In connection with the proposal outlined in Section 1 above, the Company intends to consolidate the following Share classes by merging the relevant 'Investor' Share class into the "Institutional" Share class. Immediately following the merger, the Company further intends to change the name of the consolidated Share class as further detailed in the table below. It is proposed that the Share class mergers and Share Class name change will take effect on the Effective Date.

Please see **Appendix II** to this Notice which sets out further information about the proposed Share class mergers. Please note that the terms and conditions associated with your investment will not change.

Appendix II

Your Share Class Merger Explained

What is happening?

The Share class merger will be applied to your account on the Effective Date. As a result you will see the new Share class name as referenced above on your valuations, statements and any other correspondence you receive from the Company after this date.

Why is the change happening?

Vanguard is continually looking for ways to reduce the cost of investing for all Shareholders. On 23 October 2019 Vanguard undertook wide spread OCF reductions which resulted in a number of the existing Share classes, namely the Investor and Institutional, of certain sub-funds of the Company having the same OCF. The Share class mergers outlined in this letter remove the identically priced duplicate Share classes. Not only will this reduction create simplicity in the Vanguard Share class line up, it will also reduce the operating costs borne by Shareholders.

What does the merger process entail?

Shareholders are welcome to increase their subscription in the relevant Fund prior to the relevant cutoff for trade date Wednesday 17th June, which is two days prior to the Effective Date. Shareholders will be able to redeem their position prior to the cut-off for trade date Thursday 18th June which is one day prior to the Effective Date. Following the trade freeze, effective on the Effective Date, all positions within the relevant Investor Share class will be migrated to the Institutional Share class.

After the Effective Date, Shareholders will receive a contract notice outlining the conversion factor between the Investor and Institutional Share classes. Overall the value of the holding that a Shareholder has in a Share class will remain unchanged but the number of units will change as a result of carrying out the merger.

No change to the Ongoing Charges Figure (OCF)

The OCF represents the annual percentage charge paid by Shareholders of the relevant Share class. The OCF that applies to a Share class in which a Shareholder is invested will not change as a result of the merger of such Share class.

Will the Share class merger affect my Fund holding?

The Share class merger will not affect the value of your Fund holding as Vanguard will cover all costs in relation to the Share class mergers. The risk profiles of the Funds will not change as a result of the Share class mergers.

Can I switch out of my current Fund holding in advance to avoid being involved in the Share class merger?

Yes. You can switch your holding in the relevant fund up to the merger date, the dates and cut-offs for which you would need to instruct these instructions differs per fund. Please contact the Administrator if you decide to switch to an alternative fund(s) from our extensive range to check the relevant trading cut-

offs for the funds you are intending to switch from and to. You also have the ability to redeem your investment at any time up to the merger freeze date of 18th June 2020.

Are there any tax implications in respect of the merger?

Vanguard is unable to provide tax advice to individual investors and suggests that investors engage with their personal tax advisor to address any specific questions they may have as a result of this Notice.

Is there any impact on NAV per Share?

The position for any Shareholder invested in a relevant Investor Share class will be migrated to the equivalent Institutional Share class. These two Share classes will have different NAV values. On the Effective Date, there will be a conversion of the total number of Shares at the Investor share class NAV into an alternative number of shares at the Institutional Share class NAV. The overall value of a Shareholder's holding will not change but the number of Shares will be revised.

Do I need to take any action?

You do not need to take any action unless you wish redeem or switch.
